IT IS UNDERSTOOD AND AGREED THAT ANY AND ALL MOVEMENTS WILL BE MADE IN THE MANNER PROVIDED BY LAW, AND IN ACCORDANCE WITH THE CONDITIONS AND REGULATIONS AS HEREINAFTER SET FORTH, ALL FORMING A PART HEREOF, IN WHICH THE APPLICANT AGREES, IN THE ACCEPTANCE OF THIS PERMIT, TO ASSUME ALL LEGALL RESPONSIBILITY AND LIABILITY FOR DAMAGES TO PERSONS AND/OR PROPERTY THAT MAY ACCRUE DURING SUCH MOVEMENTS OF THE VEHICLE OR COMBINATION OF VEHICLES THROUGH THE NEGLIGENCE OF HIMSELF, HIS AGENTS OR EMPLOYEES, OR FROM ANY OTHER CAUSE, AND TO SAVE THE COUNTY OF WARREN HARMLESS THEREFROM. PROTECTIVE LIABILITY INSURANCE REQUIRED ON THIS PERMIT COVERED BY POLICY.
