NOTES FOR OUTREACH COURSE SPECIFICS CHART

Note 1: The Fire Police course is delivered by local instructors designated and approved by the Office of Fire Prevention and Control.

Note 2: No maximum student number established for these courses. Locality must provide adequate classroom for number of students present.

Note 3: Courses delivered by State Fire Instructors/Municipal Training Officers.

Note 4: Minimum/Maximum - number of students mandatory for safety during practical evolutions.

Exception: Courses conducted under the Supplemental or Municipal Training Program are not required to adhere to the minimum class sizes established. Additionally, municipal training programs may exceed the maximum number of students if safeguards are established to assure student safety and effective learning.

Note 5: Train the Trainer programs delivered by local instructors.

Note 6: Courses delivered by full-time OFPC staff members or A/R SFI in units of 4-hours.

Note 7: Developed and delivered by Department of Environmental Conservation Forest Rangers.

Note 8: Courses delivered by Academy/Regional instructors in units of 4-hours. Contact OFPC, Hazardous Materials Bureau for instructor assignment.

Note 9: County SFI's are authorized to be paid a maximum of two course units (3 hours each) annually to attend course scheduling meetings with the CFC.
