Albany man sentenced to state prison for alcohol-related crash that seriously injured scooter rider

WARREN COUNTY, NY — **Warren County District Attorney Jason Carusone** announced today that **Justin T. Myers, 27, of Albany**, has been sentenced to a state prison term of 2 to 6 years following his convictions for an alcohol-related crash that seriously injured a man who was riding a mobility scooter.

Myers was convicted of felony Vehicular Assault and misdemeanor counts of Aggravated Driving While Intoxicated and Leaving the Scene of an Incident for the January 7, 2026 collision.

The charges arose from an early morning crash on Bay Road in the Town of Queensbury in which Myers, while highly intoxicated, struck a 60-year-old man who was operating a mobility scooter. Myers did not stop to render aid and fled the scene. A Good Samaritan saw the victim in the roadway, stopped to assist him and called 911. Law enforcement located Meyers and stopped him a short distance away on Bay Road.

The victim appeared at Myers' sentencing walking with the assistance of a cane. Manon Affinito, the Director of the Warren County Crime Victim Program, read a victim impact statement on behalf of the victim, in which he described a long and difficult physical and emotional recovery since the collision, and the continuing impact of the defendant's actions on his daily life.

Before the **Hon. Warren County Judge Robert Smith** imposed sentence, Myers addressed the Court, accepted responsibility, and expressed remorse for the harm he caused. He was represented by the Warren County Public Defender's Office.

District Attorney Carusone commended the victim's resilience and those who came to his aid.

"We see these crimes far too often, and they frequently result in devastating and sometimes deadly outcomes," said District Attorney Jason Carusone. "The toughness and determination shown by the victim, along with the quick actions of a Good Samaritan who came to his assistance, likely prevented this tragedy from becoming even worse. We hope this sentence provides a measure of justice while also serving as a reminder of the very real and lasting consequences of drunken driving."

District Attorney Carusone also thanked the Warren County Sheriff's Office, first responders, and the Warren County Crime Victim Program for their work and continued support of the victim throughout the prosecution.

Warren County Jury Finds Woman Guilty of Felony Strangulation and Child Endangerment in Violent Attack on Teenager

Warren County District Attorney **Jason Carusone** announced February 13, 2026 that **Crystina Dean**, 35, of Glens Falls, has been convicted on all counts following a jury trial in Warren County Court related to a violent assault on a 14-year-old victim in February 2024.

In a unanimous jury verdict on February 13, 2026, Dean was found guilty of:

- **Strangulation in the Second Degree** (Class D Felony)
- **Assault in the Third Degree** (Class A Misdemeanor)
- **Endangering the Welfare of a Child** (Class A Misdemeanor)

The conviction stems from a harrowing incident in Glens Falls on **February 25, 2024**, during which Dean physically attacked a 14-year-old child with whom she was acquainted. The violence of the assault was so severe that the young victim required emergency transport and admission to a local hospital for treatment of her injuries.

Warren County Court Judge Robert Smith presided over the trial. Immediately following the verdict, Judge Smith remanded Dean to Warren County Jail without bail.

Sentencing is scheduled for **March 4, 2026**.

The case was prosecuted by Assistant District Attorney **Grant Jones**, serving as lead prosecutor for the first time in a felony trial, with the assistance of Assistant District Attorney **Ben Smith**. The defendant was represented by the Warren County Public Defender's Office.

"This verdict ensures accountability for a brutal attack on a vulnerable child," said **District Attorney Carusone**. "I want to specifically commend ADA Grant Jones for his exceptional work. He prepared this case meticulously and showed incredible poise and skill. Alongside ADA Ben Smith, they ensured that justice was served."

Carusone also highlighted the bravery of the survivor. "The victim, who was only 14 at the time of this attack, showed immense strength and courage by standing up to her attacker in a court of law. Her resilience is inspiring."

District Attorney Carusone added: "I want to recognize the **Director of our Crime Victim Program**, Manon Affinito, who worked tirelessly to support the victim throughout the entirety of this legal ordeal. Her dedication ensured that the victim was never alone during this difficult process."

Glens Falls man sentenced to 25-years-to-life in prison for shooting

WARREN COUNTY, NY – The Warren County District Attorney’s Office announced today that Paris J. Pettiford, also known as “Sunny Black,” 39, of Glens Falls, has been sentenced to 25-years-to-life in state prison as a persistent felony offender for the 2024 shooting of a man in Glens Falls.

Warren County Court Judge Honorable Robert Smith imposed the sentence on October 29, 2025, following Pettiford’s March 21, 2025 convictions on seven counts, including attempted murder in the second degree, assault in the first degree, multiple weapons offenses, and drug possession charges involving cocaine and fentanyl.

The charges stem from a January 24, 2024 incident in which Pettiford shot a man on North Pearl Street near Lawrence Street in Glens Falls, leaving the victim with multiple gunshot wounds from a rifle.

A Warren County jury found that Pettiford, who has multiple prior felony convictions for drug and firearm offenses, was responsible for the shooting. The victim and an eyewitness testified for the prosecution, providing key evidence that led to the conviction. During the investigation, the Glens Falls Police Department recovered a rifle equipped with an illegal high-capacity magazine capable of holding up to 119 rounds.

District Attorney Jason M. Carusone praised the work of the Glens Falls Police Department, assisted by the Warren County Sheriff’s Office, New York State Police, and the New York State Police Crime Laboratory, whose analysis of critical evidence contributed to the successful prosecution.

Carusone also commended Assistant District Attorneys Ben Smith and Grant Jones, Senior Crime Victim Specialist Michaela Choppa and Legal Clerk Emily Caivano for their diligent work on the case.

“This was an outstanding team effort that brought a violent offender to justice and helped protect our community,” Carusone said.

Man Sentenced to 18 Years to Life as Persistent Felony Offender for Illegal Handgun

WARREN COUNTY, NY – Warren County District Attorney Jason M. Carusone announced today that **Novashawn Bannister, 30, of Manhattan**, has been sentenced to **18 years to life** in state prison following his conviction for second-degree criminal possession of a weapon, a felony. The sentence was imposed by Warren County Court Judge Robert A. Smith on June 18,

2025, after the Court determined that Bannister qualified as a persistent felony offender under New York State law.

Bannister was convicted on July 30, 2024, by a Warren County jury following a five-day trial. The conviction stemmed from a December 14, 2023, traffic stop on Old Mill Lane in Queensbury, during which Warren County Sheriff's Officers discovered a loaded, unregistered .380-caliber Taurus semiautomatic handgun in Bannister's possession. The conviction was Bannister's seventh felony conviction.

Sentencing was adjourned following trial to allow for a hearing on Bannister's status as a persistent felony offender. At sentencing, Judge Smith cited Bannister's extensive criminal history, including a pending sentence for a prior felony hate crime, and evidence introduced at the hearing suggesting Bannister may have stolen the handgun from an acquaintance in South Carolina before bringing it to New York.

District Attorney Carusone praised both law enforcement and the court's handling of the matter: "This defendant's long and serious criminal record, including a pending sentence for a hate crime, underscores the ongoing threat he posed to public safety. Our office is committed to working with law enforcement to hold repeat violent offenders accountable. The community is safer today because of the strong sentence imposed by the Honorable Judge Smith in this case." Carusone also commended the responding officers: "The officers involved in this case removed a handgun from the streets that was in the possession of a convicted felon. This was good police work that helped protect our residents from potential violence."

The case was prosecuted by Assistant District Attorney Connor Smith with the assistance of First Assistant District Attorney Matthew Burin. The defendant was represented by the Warren County Public Defender's Office.

The Warren County District Attorney's Office extends its appreciation to the Warren County Sheriff's Office and all others involved in the investigation and prosecution of this case.

Indiana man headed to prison for child rape charges in Warren County

WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that **Tyler A. Harmon, 25, of Indiana** has pleaded guilty to three rape charges for sexual encounters in Warren County with a teenage girl whom he met through social media.

Harmon, of Warsaw, Indiana, pleaded guilty Friday, February 7, 2025, to three felony counts of third-degree rape for sexual assaults of the teen that began in 2022 when she was 15 years old. Harmon was arrested on October 15, 2024, by police in Indiana after an investigation by New York State Police and Indiana State Police. Investigators determined Harmon became acquainted with the girl via social media channels and met her at a local hotel during three visits to Warren County where the rapes occurred.

The charges, which do not allege physical force, were filed because the victim was too young to legally consent to sexual contact. The age of legal consent in New York is 17.

Harmon is being held in Warren County Jail pending sentencing April 9, 2025 before Warren County Judge Robert Smith. He faces an anticipated sentence of 6 years in New York State prison to be followed by 10 years on post-release supervision. He will be required to register as a sex offender upon release from custody.

District Attorney Carusone said: “I want to thank Senior Investigator Paul Hill and members of the New York State Police, Indiana State Police Sergeant Justin Snyder and Detective Patrick O’Keefe as well as Warren County Assistant District Attorney Benjamin Smith for their efforts to bring this defendant to justice.”

Man sentenced to prison for fatal hit-and-run collision with pedestrian in Queensbury

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that **Peter Northup Jr., 34, of Hudson Falls**, has been sentenced to 2 to 6 years in New York State prison for leaving the scene of an incident where the defendant operated a vehicle that struck and killed a Queensbury man.

Northup entered a guilty plea in June in Warren County Court to the felony of leaving the scene of a fatal incident without reporting, in connection with the December 15 collision that resulted in the death of 30-year-old Queensbury resident **Shane M. Winchell**.

Winchell, a father of six children, had just finished work when he was hit by a minivan on Burke Drive in Queensbury that was operated by Northup. Following an investigation by the Warren County Sheriff’s Office and the New York State Police, Northup was arrested. It was determined that he was the driver of the vehicle and he made no effort to report the incident or summon help for Mr. Winchell.

Many family members and friends of the victim gathered in court as Northup was sentenced to prison on Wednesday, August 28, 2024 by Warren County Judge Robert Smith.

District Attorney Carusone said: “It is a credit to law enforcement that they were able to track down and identify the driver of the vehicle so that he could be held accountable. While there is no sentence that will bring Mr. Winchell back to his children, family and friends, the defendant will serve a prison sentence due to his callous action of leaving a young man to die on the side of the road.”

Glens Falls man sentenced to 37 years in prison for gunpoint crimes

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that a Glens Falls man who robbed two people at gunpoint and tried to rob a third person has been sentenced to 37 years in New York State prison.

Joshua M. Heym, 28, was found guilty of three felony charges, two counts of second-degree robbery and one count of attempted robbery, after a nine-day trial in May and June 2024 before Warren County Judge Robert Smith.

The charges stemmed from incidents in Glens Falls from January 10 through January 12, 2023, in which the defendant pointed a handgun at victims to rob them or attempt to rob them of money. The defendant was wearing a mask to obscure his face, but because he was on parole for a prior felony conviction, he was required to wear an ankle bracelet that tracked his movements through Global Positioning System (GPS) data. That data placed the defendant at each crime scene and was corroborated by 911 recordings, surveillance footage, and witness testimony.

On Wednesday, July 31, 2024, Judge Smith sentenced Heym to 15 years in prison for each robbery conviction, along with 7 years on the attempted robbery count. The sentences are to run consecutively, followed by 5 years of post-release supervision.

Warren County District Attorney Jason Carusone said: “These brazen crimes were committed on unsuspecting victims while the defendant was released under parole supervision for prior crimes. Thankfully, the Glens Falls Police Department, and an astute parole officer, helped to find the person responsible so he could be brought to justice. Assistant District Attorney Avi Goldstein and First Assistant District Attorney Matthew Burin did an excellent job presenting the case to the jury and now the Court’s sentence serves to protect the public from further harm.”

Heym was represented by attorneys Tucker Stanclift and Taalib Horton.

Man convicted of felony weapon charge during Warren County trial stemming from handgun seizure

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that a Warren County Jury returned a guilty verdict Tuesday, July 30, 2024 in the case of a New York City man who was arrested with an illegal loaded handgun in Queensbury last December. **Novashawn Bannister, 29, of Manhattan**, was found guilty of criminal possession of a weapon in the second degree, a felony, during a five-day trial in Warren County Court. The charge stemmed from Bannister’s arrest by Warren County Sheriff’s Officers during a December 14, 2023 traffic stop on Old Mill Lane.

Bannister, who has multiple prior felony drug-related convictions, faces up to 25-years-to-life in NY state prison if deemed a “persistent felon” when sentenced September 18, 2024 by Warren County Judge Robert Smith. Bannister is being held in Warren County Jail pending sentencing. District Attorney Carusone praised the work of the Warren County Sheriff’s Officers who encountered Bannister during a traffic stop in a residential neighborhood and safely confiscated a loaded .380-caliber Taurus semiautomatic handgun.

District Attorney Carusone said: “The officers involved in this case removed a handgun from the streets that was in the possession of a convicted felon. This was good police work that helped protect our residents from potential violence.”

The case was prosecuted by Warren County Assistant District Attorney Connor Smith with the assistance of 1st Assistant District Attorney Matthew Burin. The Warren County Public Defender's Office represented the defendant.

Glens Falls man convicted of three felonies for robberies, attempted robbery

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that a Glens Falls man was convicted, after a jury trial, of two counts of second-degree robbery and one count of attempted second-degree robbery for gunpoint incidents that occurred in Glens Falls in January 2023.

A Warren County jury convicted Joshua M. Heym, 28, on three felony charges Friday, May 31, 2024 after a nine-day trial before Warren County Judge Robert Smith. The charges stemmed from incidents in Glens Falls January 10-January 12, 2023, in which the defendant pointed a black handgun at victims to rob them or attempt to rob them. A small amount of cash was stolen during each robbery.

The defendant was wearing a mask to obscure his face, but because he was on parole for a prior felony conviction, he was required to wear an ankle bracelet that tracked his movements through Global Positioning System (GPS) data. That data placed the defendant at each crime scene and was corroborated by 911 recordings, surveillance footage, and witness testimony.

Warren County District Attorney Jason Carusone said: "These were very serious crimes against unsuspecting victims, and we are gratified that the jury returned these just verdicts. I would like to thank members of our community, both private citizens and members of local businesses, for coordinating with the Glens Falls Police Department's investigation. The assistance from the community proved to be crucial to obtaining justice in these matters. I also want to praise Assistant District Attorney Avi Goldstein and First Assistant District Attorney Matthew Burin for handling the trial. Also integral in the preparation was the work of Assistant District Attorney Benjamin Smith and Legal Clerk Deondra Davis."

Heym was remanded to the Warren County Jail, and sentencing is scheduled in Warren County Court on July 31, 2024. Second-degree robbery is punishable by up to 15 years in NY state prison.

15-to-life prison sentence for double fatal motorcycle crash in Warren County

Defendant sentenced as ‘persistent felon’

WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that **Anthony J. Futia** was sentenced to 15-years-to-life in New York State prison in connection with a fatal motorcycle collision in Lake George that occurred on June 12, 2022.

Futia, 34, of Albany, pleaded guilty in January 2023 to aggravated vehicular homicide for causing the death of two people and second-degree assault for causing serious physical injury to a third person. He also entered guilty pleas to misdemeanor charges of driving while ability impaired by combined influence of drugs and alcohol; reckless driving; and aggravated unlicensed operation of a motor vehicle.

The defendant was the subject of a persistent felony offender hearing on October 26th, 2023 where prosecutors presented evidence of the defendant’s extensive criminal history. Following that hearing, Warren County Court Judge Hon. Judge Robert Smith found that Futia should be treated as a persistent felony offender and serve up to life in prison. On Tuesday, February 6, 2024, Judge Smith sentenced Futia to 15 years to life in prison after hearing two victim impact statements.

The charges to which Futia pleaded guilty stemmed from a June 2022 collision that occurred off Route 9 in Lake George.

Futia drove a motorcycle, without a license, while impaired by cannabis and alcohol at a high rate of speed into a family that was walking on Warren County Bikeway near the Bloody Pond Road intersection. Futia struck three people, killing Lake George residents Jamie Persons, 38, and Quinton Delgadillo, 8, and seriously injuring Delgadillo’s mother, Jasmine Luellen.

District Attorney Carusone said: “This case has been devastating for the families involved and many members of our community. Today’s life sentence holds the defendant accountable for his selfish and reckless actions. The surviving family members have exhibited remarkable strength throughout this process and I hope this sentence provides them some peace. We as a community are safer when people like Anthony Futia are imprisoned.”

District Attorney Carusone had special thanks for those community members who stopped to help the victims and provided emergency medical care in an effort to save lives. He went on to recognize the work of first responders and the New York State Police for their thorough investigation, and the Warren County Sheriff’s Office for their assistance. Lastly, he thanked Warren County Assistant District Attorney Ben Smith and Legal Clerk Stephanie DeFalco for their assistance in the prosecution of the case.

Lake Luzerne man pleads guilty for infant assault

WARREN COUNTY, NY – **Warren County District Attorney Jason Carusone** announced today that **Robert Rivers, 36, of Lake Luzerne** pleaded guilty on Tuesday, February 6, 2024 in Warren County Court to reckless assault of a child for shaking an infant in his care, causing a serious head injury that required extensive hospitalization.

Rivers is expected to receive a sentence of 3.5 years in NY state prison, to be followed by 3 years of post-release supervision. An order of protection bars him from having contact with the child.

The Hon. Warren County Judge Robert Smith remanded Rivers to Warren County Correctional Facility without bail pending sentencing on Wednesday, February 21, 2024, at 9:30 a.m.

District Attorney Carusone thanked the New York State Police for their thorough investigation that led to the conviction of Rivers.

The District Attorney's Office has no further comment on the matter pending sentencing.

Sexual assault of elderly woman leads to lengthy prison term

WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that a Nebraska man has been sentenced to 15 years in New York State prison followed by 10 years of post-release supervision for attacking an elderly Warren County woman in her home in August 2021.

Samaan Adenti, 23, pleaded guilty to first-degree sexual abuse and second-degree burglary, both felonies, for crimes that occurred in the Town of Warrensburg on August 13, 2021. Adenti entered the woman's home and forcibly subjected her to sexual contact before fleeing. He had no prior connection to the victim, and was identified as the perpetrator through DNA tests performed on evidence that he left at the scene.

Before beginning his New York State prison sentence, the defendant must first serve a sentence of 20-years-to-life in prison for the sexual assault and robbery of a woman that occurred in central Vermont days after the attack in Warren County. The victim in that case was a good Samaritan who tried to help him with a purported car problem.

The Warren County case was investigated by the Warren County Sheriff's Office. The Hon. Robert A. Smith, Warren County Judge, imposed sentence in the case.

District Attorney Carusone said: “This is a uniquely disturbing case where a complete stranger entered the victim’s rural home in the middle of the day and sexually assaulted her during a burglary. Tragically the defendant immediately fled to Vermont where he committed a vicious sexual assault and robbery before he could be identified as a suspect in New York. He was eventually captured in New Hampshire committing property crimes shortly after the New York and Vermont sexual assaults. The combined efforts of the Warren County Sheriff’s Office, the New York State Police Crime Lab, along with law enforcement in Vermont and New Hampshire were critical in the investigation, identification and prosecution of the defendant who now faces a combined sentence of 35 years to life for these heinous crimes. Should he ever be released, he will have to register as a sex offender and be supervised by parole. Our hearts go out to the victims and their families.”

Man sentenced to jail, probation for unlawful surveillance

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that Hon. Robert A. Smith, Warren County Court Judge, sentenced Mark L. Siciliano to 6 months of incarceration and 5 years of felony probation on three felony counts of Unlawful Surveillance in the Second Degree. The Court also ruled that the defendant would be required to register as a sex offender pursuant to the New York Sexual Offender Registration Act. The victim, who spoke at the time of sentencing, described how the defendant’s actions have negatively impacted her life.

Siciliano, 46, of Loudonville, was convicted of using his cellular phone to photograph a young woman while she showered at Warrensburg Travel Park and Riverfront Campground on a day in August 2022. Trial evidence showed that Siciliano was discovered by the victim’s boyfriend, who quickly confronted the defendant and forced him to delete the photograph. Siciliano was located and arrested by members of the New York State Police shortly after the incident. Carusone thanked the New York State Police, and assistant district attorneys Ben Smith and Connor Smith for their efforts to seek justice for the victim.

District Attorney Jason Carusone said: “The victim’s strength and resolve in this case has helped to hold this defendant accountable for his egregious violation of her privacy. The Court’s sentence provides long-lasting protections to the community through incarceration, supervision, and registration.”

Siciliano was represented by attorneys Stephen Coffey Esq. and Michael Lawson Esq. The defendant has posted bail set by the appellate court pending appeal.

**Warren County jury convicts man of unlawful surveillance in
campground shower**

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that a Warren County Jury returned guilty verdicts against a Loudonville resident who illegally photographed a woman in a campground shower building on August 6, 2022. Mark L. Siciliano, 46, was convicted Thursday in Warren County Court for using his cellular phone to photograph a young woman while she showered at the Warrensburg Travel Park and Riverfront Campground. The jury found Siciliano guilty of three felony counts of Unlawful Surveillance in the Second Degree.

Trial evidence showed that Siciliano was discovered by the victim's boyfriend, who quickly confronted Siciliano and forced him to delete the photograph. Siciliano, who was a regular visitor at the campground, was located and arrested by members of the New York State Police shortly after the incident.

Warren County District Attorney Jason Carusone said: "I thank the jury for returning a just verdict that holds the defendant accountable. I truly appreciate the work of those who investigated the case, including New York State Police Troopers Timothy Hanaburgh and Anthony Ward, as well as the efforts of lead prosecutor Ben Smith who was assisted by ADA Connor Smith."

Siciliano was remanded to the Warren County Jail. Sentencing is scheduled before Judge Robert Smith in Warren County Court on January 3rd, 2024 at 9:30 AM.

NY State's highest court rejects appeal of former Lake George Watershed Coalition's convictions

David Decker expected to surrender for sentence on November 17

WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that the New York State Court of Appeals has declined to hear the appeal of **David J. Decker**, the former director of the Lake George Watershed Coalition who was convicted of stealing hundreds of thousands of dollars of public funds while in charge of local environmental projects.

In a decision released this week, the Court of Appeals, New York State's highest court, declined to review the mid-level appeals court's ruling from July 2023 that affirmed Decker's convictions and sentence.

The Appellate Division 3rd Department previously upheld the decision of a Warren County jury that convicted Decker in March 2020 after a month-long trial. The Appellate Division found that that trial evidence supported David Decker's convictions for grand larceny and fraud as well as

false filings relating to his tax returns. That decision held that there were no grounds to overturn his convictions or sentence.

At trial the Warren County District Attorney's Office presented evidence that showed he stole hundreds of thousands of dollars in NY State and federal grant funds while overseeing environmental projects in the Lake George region.

Decker, a resident of Burnt Hills, was refusing to pay local municipalities, not-for-profit organizations, and businesses by misleading these entities into believing that grant funds had not yet been received when in fact they had been diverted into his personal accounts. The evidence also showed that Decker failed to report thousands of dollars of income, including funds he obtained and funneled through a youth basketball tournament scheme.

District Attorney Carusone said: "Despite his convictions and sentence the defendant has remained at liberty pending the appeals process. Now, the decision of the Court of Appeals means the defendant's sentence will begin, including the requirement that he pay restitution to the victims. He will be directed to surrender himself to begin serving the sentence that was imposed for his betrayals of the public trust. As District Attorney for Warren County I am thankful for the tireless work of those who investigated and prosecuted this lengthy and complicated case. I commend the Warren County Sheriff's Office, New York State Office of the State Comptroller, and the New York State Department of Taxation and Finance for their efforts to seek justice. I am particularly thankful to Assistant District Attorney Ben Smith and Acting Assistant District Attorney Christine Stevens for the tireless work they put into presenting this complex case to the jury. Finally, I am grateful for the efforts of Assistant District Attorney Bob McCarty who reviewed thousands of pages of transcripts so that he could successfully respond to the defendant's appeals."

It is expected that the defendant will be required to appear at the Warren County Court on November 17th to begin his sentence.

Man sentenced to up to 6 years in prison for fatal DWI crash

WARREN COUNTY, NY, 11/4/23 -- Warren County District Attorney Jason Carusone announced today that Michael Campbell II, of Granville was sentenced to 2 to 6 years in the New York State prison system for his guilty plea to causing a fatal drunken driving crash in Queensbury earlier this year.

Campbell, 40, pleaded guilty to second-degree vehicular manslaughter, a felony, in connection with the May 3, 2023 head-on collision on Quaker Road that claimed the life of a 33-year-old Nicholas Canning of Queensbury. Campbell's blood-alcohol content was found to be 0.13% after the collision.

Campbell was found to be intoxicated after the crash and admitted he had been drinking beer in the hours before the crash. He pleaded guilty to the top charge he faced, and Warren County Judge Robert Smith imposed sentence on Friday, November 3.

District Attorney Carusone thanked the civilian witnesses who stopped at the crash scene to render aid to the victim.

"Their efforts immediately after the crash were crucial in helping Patrol Officer Will Greene, Sgt. Ben Geisler, and Investigator Jesse Wittenberg, all members of the Warren County Sheriff's Office, and New York State Police Trooper Joseph Port to put together an excellent investigation," Carusone said. He went on to praise the work of Warren County First Assistant District Attorney Matthew Burin, who was the chief prosecutor for the case, the director of victim assistance program Manon Affinito, and Deondra Davis, who served as the legal clerk.

Queensbury man pleads guilty for knifepoint robbery

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that Justin M. Cabral, 36, of Queensbury has pled guilty to first-degree robbery, a felony, for the knifepoint robbery of a clerk at the Speedway gas station/convenience store on Aviation Road in Queensbury on the morning of July 04, 2023. Honorable Warren County Judge Robert Smith sentenced the defendant, a prior felon, to 13 years in NY State prison to be followed by 5 years of post-release supervision.

An accomplice in the case, Garrett A. Murray, 25, of Greenwich, who drove the getaway vehicle, had previously pled guilty to third-degree robbery, a felony, and awaits sentencing for his role in the case.

Carusone said the store clerk's calm demeanor and the rapid response by law enforcement led to the swift capture of both defendants.

Carusone complimented NY State Trooper Jason Heggelke's quick reaction in securing Cabral who, after leaving the getaway vehicle, attempted to flee on foot across the Northway. Carusone thanked NY State Police investigators Justin Mootz and Jon Deyette, along with other members of law enforcement, who identified and arrested the driver of the getaway car.

Man pleads guilty in connection with Queensbury shooting

Warren County District Attorney Jason Carusone announced today that **Adrian A. Simental, of Moreau**, pleaded guilty to two felony charges in connection with a November 27, 2022 shooting in Queensbury that left another man seriously injured.

Simental, 34, pleaded guilty to charges of **second-degree assault** and **second-degree criminal possession of a weapon** for the shooting at the Walmart store on Route 9 in Queensbury.

Simental fired a handgun into the torso of the victim after a verbal dispute that occurred when Simental followed the victim to the store after an aggressive driving encounter on a nearby road.

Simental is being held in Warren County Correctional Facility pending sentencing by the Honorable Warren County Judge Robert Smith on September 14, 2023. Simental is expected to receive a sentence that will include 12 years in New York State prison, 3 years of post-release supervision, an order of restitution and order of protection on behalf of the victim.

District Attorney Carusone thanked the Warren County Sheriff's Office, Saratoga County Sheriff's Office and New York State Police for the investigation that led to a successful prosecution in this case.

Appeals court upholds convictions in Lake George fraud case

Warren County District Attorney Jason Carusone announced today that the Appellate Division, Third Department of NY Supreme Court has upheld the felony theft and fraud convictions of David Decker, former director of the Lake George Watershed Coalition, in a unanimous, 19-page decision.

The appeals court affirmed that trial evidence supported David Decker's convictions for grand larceny and fraud and that there were no technical errors made during his month-long trial. The Court also upheld the 8- to 24-year state prison sentence imposed by then-Warren County Judge Hon. John S. Hall Jr.

Decker, of Burnt Hills, was found guilty of six felonies, including Grand Larceny in the Second Degree and Scheme to Defraud in the First Degree, by a Warren County jury after the Warren County District Attorney's Office presented evidence that showed he stole hundreds of thousands of dollars in NY State and federal grant funds while overseeing environmental projects in the Lake George region. When questions were raised about nonpayment to local municipalities, not for profits, and businesses, David Decker misled these entities into believing that grant funds had not yet been received when in fact they had been diverted into his personal accounts. The appeals court also upheld convictions for the false filing of New York State tax returns where David Decker failed to report hundreds of thousands of dollars of income, including funds he obtained and funneled through youth basketball tournaments.

Warren County District Attorney Jason Carusone said: "We are gratified that the Appellate Division upheld all of the convictions and found there was sufficient evidence that the defendant stole public funds, and engaged in a scheme to defraud the people of Warren County."

District Attorney Carusone also praised the tireless efforts of prosecutors who worked on the trial, appellate brief, and oral argument, saying: "Assistant District Attorneys Benjamin Smith and Robert McCarty, as well as Acting Assistant District Attorney Christine Stevens from the Tax Department, put countless hours into this complicated case, and we are glad to see that their hard work has been affirmed by the Appellate Division."

Carusone went on to thank the Warren County Sheriff's Office, Office of the New York State Comptroller and New York State Department of Taxation and Finance for the many months spent investigating these crimes.

Decker has been free since the date of his conviction pending the decision on his appeal. It is anticipated he will return to Warren County Court on a future date to begin serving his sentence.

Man pleads guilty for fatal motorcycle crash in Lake George

WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that Anthony J. Futia, 33, pleaded guilty in Warren County Court to five charges in connection with a fatal motorcycle collision in Lake George on June 12, 2022.

Futia entered guilty pleas to aggravated vehicular homicide for causing the death of two people and second degree assault for causing serious physical injury to a third person. He also entered guilty pleas to misdemeanor charges of driving while ability impaired by combined influence of drugs and alcohol; reckless driving; and aggravated unlicensed operation of a motor vehicle. His pleas occurred before the Hon. Warren County Judge Robert Smith.

The charges stem from a June 12 collision that occurred off Route 9 in Lake George, when Futia drove a motorcycle at high speed off the highway onto the Warren County Bikeway near Bloody Pond Road.

Futia struck three people, killing Lake George residents Jamie Persons, 38, and Quinton Delgadillo, 8, and seriously injuring Delgadillo's mother, Jasmine Luellen.

Futia faces a potential sentence of up to 15-years-to-life in state prison if the court sentences him as a persistent felon.

District Attorney Carusone said: "This case highlights the destruction that comes from drunk and drugged driving. The defendant stands convicted for his senseless conduct, which has devastated a family and a community. Today's plea provides the victim's family some closure without the stress and uncertainty of a trial. Now, after a hearing, the defendant could face a life sentence."

District Attorney Carusone thanked first responders for their life saving efforts at the scene and he further thanked the New York State Police for their thorough investigation as well as the Warren County Sheriff's Office for their assistance.

Futia is being held at Mohawk Correctional Facility pending sentencing. No sentencing date has been set.

Man convicted of felony, misdemeanors during trial in Warren County Court

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that Robert S. Hedrick was convicted of Aggravated Criminal Contempt, a class D felony, and misdemeanors of resisting arrest, and false personation in Warren County Court on Friday evening, January 20, 2023, after a week-long trial. The case was prosecuted by Warren County Assistant District Attorney Connor Smith, with Assistant District Attorney Avi Goldstein serving as second chair.

The Warren County jury heard evidence that Hedrick, 31, intentionally violated a court order by having contact with a protected party. When Hedrick was confronted by police he gave a false name, ran, and resisted Glens Falls Police officers. The violation of the order of protection was observed by law enforcement and other witnesses.

Carusone thanked the members of the Glens Falls Police Department who investigated the case, and commended the other witnesses for coming forward and seeing the case through to verdict.

Carusone said: "This crime was solved due to the diligence of a member of the public, along with the quick action of the Glens Falls Police Officers who secured the defendant. The defendant's flagrant disregard for the court's order, false statements to the police and resisting arrest have all been proven and now he must account for those choices."

Hedrick was remanded to Warren County Jail. Warren County Court Judge Hon. Robert A. Smith set a sentencing date of February 03, 2023.

Man indicted in connection with Queensbury shooting

Warren County District Attorney Jason Carusone announced Friday, January 6, 2023 that a Warren County grand jury has filed a six-count indictment against Adrian A. Simental, 33, in connection with a November 27, 2022 shooting in Queensbury.

Simental faces the following charges:

- Criminal Possession of a Weapon in the Second degree, firearm (felony)
- Criminal Possession of a Weapon in the Second degree, loaded firearm (felony)
- Criminal Possession of a Weapon in the Fourth degree (misdemeanor)
- Menacing in the Third Degree (misdemeanor)
- Attempted Assault in the First Degree (felony)
- Assault in the Second Degree (felony)

Simental pleaded not guilty during arraignment Wednesday, January 4, 2023 before Warren County Judge Robert Smith, and was remanded to Warren County Jail for lack of bail. He is due back in Warren County Court on February, 15, 2023.

The charges stem from an incident in the parking lot of the Walmart store at 891 Route 9 in Queensbury, during which Simental is accused of firing a handgun at another man.

Queensbury man convicted of sex offenses during trial in Warren County

(10/24/22) WARREN COUNTY, NY -- **Warren County District Attorney Jason Carusone** announced today that Jose Omar Aguilar Gomez of Queensbury was convicted of felony charges of Predatory Sexual Assault Against a Child and Sexual Abuse in the First Degree and misdemeanor Endangering the Welfare of a Child In Warren County Court on Friday, October 21, 2022, after a week-long trial.

The trial jury heard evidence that Gomez, 28, engaged in a course of sexual conduct against a child under 11 years old. The case was prosecuted by Warren County Assistant District Attorney Benjamin Smith with Assistant District Attorney Connor Smith serving as second chair. The Director of the Warren County Crime Victims Assistance Program, Manon Affinito, worked closely with the victim and their family.

District Attorney Carusone said: "This child victim, who had been through so much trauma, bravely faced their abuser in court and gave compelling testimony that was supported by DNA and medical evidence. I'm grateful that the jury's verdict will hold the defendant accountable and provide some justice for this young victim."

District Attorney Carusone also thanked the members of the New York State Police who investigated the case with special emphasis on Sgt. Adam Norton, Investigator Cecile Labarron and Forensic Scientist Kristine Robinson. He also praised the tireless efforts of the staff of the Warren/Washington County Child Advocacy Center, Nadia Giumarra, Director of the Sexual Assault Nurse Examiner program at Glens Falls Hospital, and the many other medical professionals who assisted in treating the child victim.

Warren County Court Judge Hon. Robert A. Smith scheduled a sentencing date of December 2nd, 2022. Gomez faces a minimum sentence of 10-years-to-life and a maximum of 25-years-to-life in state prison on the top count of Predatory Sexual Assault Against a Child. The defendant

was remanded to Warren County Jail by the court and is also held in custody by a U.S. Immigration & Customs Enforcement detainer.

Queensbury man pleads guilty in child sexual assault case

(October 5, 2022)

WARREN COUNTY, NY – Warren County District Attorney Jason Carusone announced today that Brian A. Combs, of Queensbury, pleaded guilty Wednesday, October 5, 2022 to one felony count of Course of Sexual Conduct Against a Child in the First Degree. The guilty plea occurred before the Hon. Warren County Judge Robert A. Smith.

As a result of the plea, Combs agreed to serve 10 years in a state correctional facility, serve an additional 10 years of post-release supervision when he is released, register as a sex offender and provide a sample of his DNA for the New York State Database. Sentencing is scheduled in Warren County Court on November 16th, 2022.

Warren County District Attorney Jason Carusone said: “The victims showed true bravery by coming forward to law enforcement and standing firm through the course of the prosecution. Their resolve and the State Police investigation helped our office hold the defendant accountable and protect the community from this sexual predator.”

The case was investigated by the New York State Police and was prosecuted by Warren County Assistant District Attorneys Benjamin Smith and Ann Vondrak, with the assistance of Senior Crime Victim Specialist Manon Affinito.

The defendant is being held in the Warren County jail pending sentencing.

New indictment filed in Lake George fatal crash case

(September 27, 2022)

WARREN COUNTY, NY – Warren County District Attorney Jason Carusone announced today that a superseding indictment has been filed against an Albany man accused of crimes in connection with a fatal motorcycle crash in Lake George on June 12th, 2022.

Anthony J. Futia faces 15 charges, with a Warren County grand jury adding two (2) new felony charges of aggravated vehicular homicide. In addition to the new charges, Futia continues to face three (3) other counts of aggravated vehicular homicide, two (2) counts of second-degree manslaughter, two (2) counts of vehicular assault and one (1) count of second-degree assault, all felonies. He also is accused of misdemeanor charges of driving while intoxicated, driving

while under the combined influence of drugs and alcohol, reckless driving and aggravated unlicensed operation of a motor vehicle.

Futia will be arraigned on the new indictment on a future date. He is being held in custody pending further court action.

The charges stem from an incident the afternoon of June 12 where Futia is accused of driving a motorcycle from Route 9 onto Warren County Bikeway, striking a group and leading to the death of an 8-year-old boy, serious injury to the boy's mother, and the death of her 38 year old fiancé. The accused is afforded the legal presumption of innocence.

As the case is pending, the District Attorney's Office will have no further comment on the matter at this time.

Queensbury man receives 20-year prison sentence for child sexual abuse

WARREN COUNTY, NY – Warren County District Attorney Jason Carusone announced September 16, 2022 that Zachary A. Mead has been sentenced to 20 years in a state correctional facility to be followed by 20 years of post-release supervision for child sexual assault. The sentence was imposed Friday by the Honorable Warren County Judge Robert A. Smith.

Mead, of Queensbury, entered a guilty plea to Course of Sexual Conduct Against a Child in the First Degree, a felony, on May 25th, 2022 while jury selection in his trial was ongoing. The charge stemmed from repeated sexual assaults of a child.

The defendant later attempted to withdraw his plea and that request was denied by Judge Smith.

Carusone praised the work of Warren County Assistant District Attorney Benjamin Smith and his co-counsel, First Assistant District Attorney Matthew Burin. Carusone also complimented the Warren and Washington Counties CARE Center for their work with the victim, and the investigate efforts of the Warren County Sheriff's Office.

District Attorney Carusone said: "This case was protracted due to the COVID-19 pandemic, and yet the victim and her family remained strong throughout the process. This sentence holds the defendant accountable and serves to protect the community from this sexual predator." Mead will be required to register as a sex offender and a sample of his DNA will be entered into the New York State DNA database.

Glens Falls man pleads guilty for bank robbery

WARREN COUNTY, NY – Warren County District Attorney Jason Carusone announced Friday, September 16, 2022 that Joseph L. Skellie has pleaded guilty to Robbery in the third degree, a felony, for the March robbery of a bank branch in Glens Falls.

Skellie, of Glens Falls, pleaded guilty Friday, September 16, 2022 before Honorable Warren County Judge Robert Smith for robbing Glens Falls National Bank on Broad Street on March 28, 2022. The Glens Falls Police Department investigation determined that while the defendant did not use or display a weapon, he did submit a handwritten note to a bank teller demanding money.

An undisclosed amount of money was stolen, and the robbery note was recovered during the investigation.

Skellie is expected to be sentenced on October 5, 2022 to an indeterminate term of imprisonment of 3 1/2 - 7 years in prison, which is the maximum sentence for a predicate felon on the charge of Robbery in the third degree. He is being held in Warren County Jail pending sentencing.

New York City man headed to prison in heroin, crack cocaine case

WARREN COUNTY, NY – Warren County District Attorney Jason Carusone announced Monday, September 12, that Saquan Lamont entered guilty pleas to all charges pending against him in an indictment brought for possession of cocaine and heroin.

The guilty pleas occurred as a jury trial was beginning in the case Monday in Warren County Court. Lamont pleaded guilty to felony charges of first-degree criminal of a controlled substance and third-degree criminal possession of a controlled substance and two (2) misdemeanor charges of criminally using drug paraphernalia.

Lamont, of New York City, was arrested with 11 ounces of crack cocaine and 1.48 ounces of heroin during a traffic stop by State Police March 21, 2021 in Queensbury.

The honorable Warren County Court Judge Robert Smith is expected to sentence the defendant to 10 years in New York state prison to be followed by up to 5 years of post release supervision. Sentencing is scheduled on December 21, 2022.

District Attorney Carusone complimented the work of New York State Police Trooper Peyton Ogden and Investigator Aaron Mound for their handling of the case. Carusone thanked First Assistant District Attorney Matthew Burin and Assistant District Attorney Grant Jones for their work preparing the case for trial.

The defendant was represented by Taalib Horton. The defendant is being held on bail in the Warren County Jail pending sentencing.

Man pleads guilty in rape case

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced today that Bruce Haywood, of Indianapolis, Indiana, pleaded guilty Friday, September 2, 2022 to all charges in an indictment that charged him with three felony counts of Rape in the Third Degree and one misdemeanor count of Endangering the Welfare of a Child.

The plea occurred in Warren County Court at the commencement of trial, just prior to the beginning of jury selection.

Warren County Court Judge Hon. Robert A. Smith indicated that the defendant would be sentenced up to eight years in a state correctional facility when sentencing occurs on October 20th, 2022, at 11 a.m. The defendant is free on bail pending sentencing, and sentence enhancement warnings were issued by Judge Smith if the defendant violates bail or release conditions before sentencing.

The case was prosecuted by Warren County Assistant District Attorneys Benjamin Smith and Morgan Cosentino. The case was investigated by the Glens Falls Police Department.

District Attorney Carusone announces 13-count indictment for Lake George motorcycle fatalities

WARREN COUNTY, NY -- Warren County District Attorney Jason Carusone announced Tuesday that Anthony J. Futia has been indicted on 13 charges by a Warren County Grand Jury in connection with the June 12th motorcycle crash in Lake George that resulted in the deaths of an 8-year-old boy and a man who was walking with the boy.

Futia, 33, of Albany, pleaded not guilty to the indictment Tuesday before the Honorable Warren County Judge Robert Smith, and was remanded to the custody of the Warren County Sheriff's Office pending further court action.

Full orders of protection were issued for the survivors of the collision. The defendant was represented by the Warren County Public Defender's Office.

The indictment includes counts of aggravated vehicular homicide, a Class B Felony punishable by up to 8-1/3 to 25 years in state prison, and lesser felony charges of second-degree manslaughter, aggravated vehicular assault and second-degree assault, as well as the misdemeanors of driving while intoxicated, driving while ability impaired by the combined influence of alcohol and any drug or drugs, reckless driving and aggravated unlicensed operation of a motor vehicle. The charges stem from an incident the afternoon of June 12 where Futia is accused of driving a motorcycle onto Warren County Bikeway, striking a group on the bike path near Bloody Pond Road.

The Warren County District Attorney's Office has no further comment on this case at this time.
