RESOLUTION MAKING SEQRA DETERMINATION REGARDING THE PROPOSED LAKE GEORGE ENVIRONMENTAL PARK PROJECT IN WARREN COUNTY, NEW YORK AND THE AUTHORIZATION BY SERIAL BOND RESOLUTION OF SAME DATE FOR THE ISSUANCE OF UP TO \$612,000 SERIAL BOND OF WARREN COUNTY TO PAY THE COST OF CERTAIN COMPONENTS OR FEATURES THEREOF

WHEREAS, the Warren County Board of Supervisors is proposing construction of certain components or features of the Lake George Environmental Park, namely two (2) pedestrian bridges, a reinforced turf festival area, outdoor lighting and pedestrian pathways and authorization to issue up to Six Hundred Twelve Thousand Dollars (\$612,000) Serial Bond of Warren County to pay the cost thereof ("the Project"), and

WHEREAS, the Project is subject to the requirements of the State Environmental Quality Review

Act (SEQRA) pursuant to 6 NYCRR Part 617, and

WHEREAS, the Warren County Board of Supervisors has reviewed the proposed Project and Part
