## CERTIFICATE OF INCORPORATION

OF

THE WARREN COUNTY LOCAL DEVELOPMENT CORPORATION UNDER SECTION 402 OF THE NOT-FOR-PROFIT CORPORATION LAW

WE, THE UNDERSIGNED, for the purpose of forming a local development corporation pursuant to Sections 402 and 1411 of the Not-for-Profit Corporation Law of the State of New York, do hereby certify:

1. The name of the proposed corporation shall be:
THE WARREN COUNTY LOCAL DEVELOPMENT CORPORATION.

The Corporation shall be in accord with the definition set forth in N-PCL § 102(a)(5).

- The purposes for which it is to be formed are to 2. relieve and reduce unemployment, to promote and to provide for additional and maximum employment, to better and to maintain job opportunities, to instruct or train individuals to improve or to develop their capabilities for jobs, to carry on scientific research for the purpose of aiding a community or geographical area by attracting industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, and to lessen the burdens of government and to act in the public This local development corporation is a corporation under Section 201 of the interest. Type C corporation under The lawful public or Not-for-Profit Corporation Law. quasi-public objective which each of the foregoing purposes will achieve are to foster employment opportunities and to promote the general and public welfare of the people.
- All income and earnings of such corporation shall be used exclusively for its corporate purposes or accrue and be paid to the New York Job Development Authority.
- 4. No part of the income or earnings of such corporation shall inure to the benefit or profit of, nor shall any distribution of its property or assets be made to any member or private person, corporate, or individual, or any other private interest except for the repayment of loans.
- 5. If the corporation accepts a mortgage loan from the New York Job Development Authority, the corporation shall be dissolved in accordance with the provision of Section 1411(g) upon the repayment or discharge of loan in full.

- The office of the corporation is to be located in the County of Warren, New York.
- 7. The number of directors of the corporation shall be not less than three (3) and not more than twenty (20).
