**Welcome & Call to Order:** Board Chair Mike Wild called the meeting to order at 11:02 am on Thursday, April 24, 2026. The meeting was held in person. A quorum was present. The meeting was live streamed on YouTube.

**Review of March 19, 2026 BOD Meeting Minutes and ANNUAL BOD Meeting Minutes:**

The board reviewed the March 19, 2026 Board of Directors Meeting Minutes and ANNUAL Board of Directors Meeting Minutes. There were no comments or questions. Motion to approve both minutes was made by Bob Landry; seconded by Nancy Turner; all in favor; motion carried.

**Financial Update:** WCLDC CFO Diane Dumouchel reviewed the March 2026 Financials and Loan Portfolio.

**Loan Portfolio:** WCLDC CFO Diane Dumouchel noted that Kirsh Helmets Inc. was not current nor responsive to efforts to connect. The board discussed possible actions. A resolution was drafted to request of the WCLDC's legal counsel to send a formal letter notifying the loan recipient that failure to cure delinquency will result in acceleration towards litigation. The WCLDC Board also requests a quote for the expected costs associated with said litigation. Motion to approve the resolution made by Bob Landry; seconded by Nancy Turner; all in favor; motion carried.

**EDC President/Staff Report:** President Jim Siplon introduced new team members, Eric Rosenfield, Economic Development & Communications Coordinator and Mary Feldman, Transformational Change in Rural Child Care Lead. He also shared the success of current intern Cameron Porter and incoming intern Maddisyn Griffin, both Queensbury High School Seniors and part of BOCES Early College Program. Mike Wild shared interest in having Mary Feldman present at the next Warren County Economic Growth & Development Committee. Mr. Siplon discussed recent interest in property development and the opportunity for the LDC it may provide; the upcoming City Planning Committee meeting surrounding the Cellular Overlay project and Tech Meadows development proposal; the MOSAIC arts and culture coalition; and two new housing proposals in the outlying communities. Dave Strainer briefly discussed the potential for properties the County may be looking to sell in the future.
